**ORDINANCE AMENDING CHAPTER XXXV (LAND USE), ARTICLE XIV,
(HISTORIC PRESERVATION COMMISSION), SECTION 14-1 (HISTORIC
PRESERVATION COMMISSION; MEMBERSHIP) OF THE REVISED
GENERAL ORDINANCES OF THE TOWNSHIP OF MILLSTONE, COUNTY
OF MONMOUTH, STATE OF NEW JERSEY**

BE IT ORDAINED by the Township Committee of the Township of Millstone, County of Monmouth, State of New Jersey, as follows (additions are underlined, and deletions are in [brackets]):

I

Chapter XXXV, Land Use, Article 14, Historic Preservation Commission, Section 14-1, Historic Preservation Commission; Membership, is hereby amended to read as follows:

14-1 HISTORIC PRESERVATION COMMISSION; MEMBERSHIP.

14-1.1 No change.

14-1.2 Membership.

The Commission shall consist of ~~nine (9)~~ seven (7) members and two (2) alternate members, appointed by the Mayor. The Commission shall include members from each of the following classes:

a. No change.

b. No change.

c. Class C – Regular members who are not designated Class A or B shall be designated Class C. Class C members shall be citizens of the municipality who shall hold no other municipal office, position or employment, except for membership on the Planning Board or Board of Adjustment. Of the regular members, a total of at least ~~four (4)~~ three (3) must be of Class A and B.

d. No change.

No member of the Commission shall be permitted to act on any matter in which he or she has, directly or indirectly, any personal or financial interest.

14-1.3 Term, Vacancies, Removal.

Regular members shall serve for a period of four (4) years. ~~Initial appointments, however shall be made in the following manner:~~

~~Three (3) regular members appointed for three (3) years.~~

~~Three (3) regular members appointed for two (2) years.~~

~~Three (3) regular members appointed for one (1) year.~~

~~Alternate number 1 for two (2) years.~~

~~Alternate number 2 for one (1) year.~~

~~Thereafter, the term of a regular member shall be four (4) years and the~~ The term of an alternate member shall be two (2) years. If the members of the Planning Board and/or Board of Adjustment are appointed to membership on the Commission, their terms on the Commission shall be concurrent with their terms on their respective Boards.

A vacancy occurring otherwise than by expiration of term shall be filled for the unexpired term only.

A member of the Commission may, after public hearing if the member so requests, be removed by the governing body for cause.

II

All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

III

If any section, subparagraph, sentence, clause or phrase of this Ordinance shall be held to be invalid, such decision shall not invalidate the remaining portion of this Ordinance.

IV

This Ordinance shall take effect upon adoption and publication according to law and filing with the Monmouth County Planning Board.
